FELONY charges, 7 years in prison, for a SILENT protest in support of immigrants?!

Stop the Political Persecution and Drop the Charges against Maya!

The **University of Chicago police** brutally attacked and arrested Maya for participating in a **SILENT** protest and charged her with **FELONY** battery on a police officer. She is also **banned** from the University of Chicago campus!

Maya (Diya) Cruz, is a member of the Revolution Club. On March 1, 2018, as part of a nationwide protest called for by **RefuseFascism.org**, to build a broad movement to drive out Trump/Pence fascist regime, she, along with three other Revolution Club members, took part in 11 minutes of silence for the 11 million undocumented immigrants who are being terrorized.

With a fascist regime in power, tearing up what are supposed to be protected civil and legal rights, and ruling through increasingly open terror and violence, this protest was needed and was right!

This imperialist system has created miserable conditions, while destroying the environment in the home countries, for the vast majority of people around the world. It is responsible for the extreme poverty and violence which forces millions to flee, seeking asylum. The U.S sits atop of this empire, creating havoc --supporting death squads, dictators and coup d'etats -- grinding up the lives of millions who are the backbone of creating the very wealth the U.S. boasts of.

What is being done to immigrants is nothing short of ethnic cleansing and is at the very core of the Trump/Pence fascist regime. There is a clear message in the attack on Maya that those trying to fight this will be criminalized.



Maya is a revolutionary and a follower of Bob Avakian, the leader of the revolution and architect of the new synthesis of communism. For her this action was part of working toward an actual revolution; for a world *without* borders, a world where no one is considered "illegal" -- a world beyond all forms of exploitation and oppression, the emancipation of all of humanity!
